The Borough of Ben Avon Council met in a regular voting session on Tuesday, June 15, 2021, virtually and at 7101 Church Avenue for the purpose of transacting General Business. President Jennifer Bett presided and opened the meeting at 7:01 PM with the Pledge of Allegiance.

PUBLIC PARTICIPATION

Tim Stokes, 234 Alder Drive

Mr. Stokes attended to voice his concern with feral cats roaming on his property and causing damage. His complaint and concerns will be forwarded to the Code Enforcement Officer, and Mr. Stokes will provide pictures to the Borough Office.

INTERN INTRODUCTION

Jaclyn Karolski, a student at the University of Pittsburgh, introduced herself to Council and shared some of the progress she has made on several projects she was assigned. Jaclyn was placed through Local Government Academy's summer intern program and will be working in the Borough until mid-August.

BOROUGH REPORTS

Mayor's Report

Mayor Hughes-Holcomb reported the new intern, Jaclyn Karolski, has taken on projects quickly and is working with her on a proposed Food Truck Ordinance. In addition, Jaclyn is working with Mrs. Roggenkamp on the Climate Action Plan and researching fundraising options for the Building Centennial Project with Mr. Wagner. She stated that Ms. Karolski is in the office Monday through Thursday, and Friday remotely from 8:30 a.m. until 4:00 p.m.

Police Report - See Attachment A

Chief Hanny reported 64 calls in the month of May, including calls of suspicious circumstances that were resolved without issue. Chief Hanny reminds residents to always report any suspicious activity in the Borough. He stated that car break-ins continue and reminded residents again to keep their valuables out of their car and the vehicle locked.

Chief Hanny also reminded residents that fireworks are prohibited in the Borough, and Ohio Township Police will post frequently asked questions about fireworks safety as the 4th approaches.

Fire Department Report – See attachment B

There was no representative from the Fire Department at this meeting.

Solicitor

Solicitor Sweeney reported the lease for Northwest EMS was submitted to them, and she is awaiting their response. The current lease expires on June 30, 2021.

Solicitor Sweeney shared the following update on the Fire Department request:

At a previous meeting council submitted a lease agreement and service agreement to the Fire Department memorializing the current understanding of the parties and the current understanding of the obligations of each party. The Fire Department did not sign either agreement. She has been attempting to schedule a meeting with them and has had multiple meetings cancelled by the Fire Department representatives. She is trying to again schedule a meeting for next week to discuss the situation with them. She will update council further if that happens. As of now, no agreements have been signed and no meeting set.

Joint Planning Commission – See Attachment C

Chris Cieslak stated the most recent minutes from the JPC meeting were submitted for Council review. She reported on developing events in Avalon and Bellevue, and stated Bellevue added two new representatives to fill vacancies on the Commission. Currently all nine Planning Commission posts are filled.

FINANCIAL REPORTS

Statement of Revenue & Expense

Mr. Opipery noted the Capital Reserve transfer in the amount of \$400,000 made last month from Capital Reserve to the General Fund will allow for upcoming road and sewer repairs. In addition, Mr. Opipery stated the revenue is up as expected, which is necessary to meet current year financial commitments.

<u>Motion:</u> Mr. Opipery; <u>Second:</u> Mr. Casale; <u>Motion Carried</u> by unanimous voice vote to approve the Statement of Revenue & Expense report as presented.

Accounts Payable

Mr. Opipery noted a payment of \$5,000.00 to the Ben Avon Fire Department shown on the report that may have been duplicated in error. He will pull that figure from the approval until it can be further investigated.

<u>Motion:</u> Mr. Opipery; <u>Second:</u> Mr. Casale; <u>Motion Carried</u> by unanimous voice vote to approve all bills on the Accounts Payable report as presented and amended in the amount of \$106,406.75.

COMMITTEE REPORTS

Administration Committee - there was no report

Public Affairs/Communications Committee

Mrs. Bett reported that the intern, Jaclyn Karolski, is preparing a draft of a Borough newsletter and mailing list for distribution. She hopes to have a draft to share with Council in July or August. Mrs. Bett stated that with the Governor lifting the emergency declaration, Council will need to decide how to hold public meetings going forward. She has been investigating a hybrid model to begin to resume in-person/virtual meetings.

Public Safety/Code Enforcement - See Attachment C

Mr. Stockle reported work continues to resolve the crumbling wall at 54 Forest Avenue. The resident was cited, but there is some question as to who is responsible for the repair. As a survey on the property was inconclusive, Mr. Stoeckle states he will work with Harshman Group to have a second survey completed.

Public Works

Mr. Opipery stated Mr. Regrut rented a sweeper and cleaned the streets with minimal disruption to traffic flow. He recommended this should be done annually. West View Water is working on Breading Avenue on replacement of the main line. This should be complete sometime next week. They will then move to Phase II. Mr. Opipery also noted that the gas company work still requires restoration.

Mr. Opipery reported a favorable response from Ben Avon Heights concerning their financial commitment to the repair of a shared section of sewer slated to be turned over to ALCOSAN. State Pipe will perform some of the repair work prior to transfer.

OV COG

Mr. Wagner reported the new Executive Director, Patrick Conners, will be meeting with the delegates at the monthly meeting tomorrow for the first time. Mr. Conners has requested time to meet with each municipality Secretary/Manager in the coming months. Mr. Wagner also reported the final draft of the solid waste contract will soon be out for bid as planned.

Mr. Wagner also reminded Council that the traveling glass bin will be available at the end of the month.

Centennial Building Committee

Mr. Wagner reported there will be two surveys completed on the Borough building. An asbestos and lead paint survey, which was funded by a grant from the Avon Club, is complete. A second survey on the site should be complete in the next week depending on the availability of the contractor. Mr. Wagner is also exploring avenues for funds management for any donations.

Climate Action Plan

Mrs. Roggenkamp stated progress has been made on the draft of the Climate Action Plan. She made a request of the working group to review the draft prior to submitting to the DEP for review. Mrs. Roggenkamp said she will forward a link to the Councilmembers of the draft copy to review as well. She would like to present the plan to Council at the August council meeting.

NEW BUSINESS

Local Fiscal Recovery Grant

Mrs. Bett reported the Borough Secretary completed the steps necessary to apply for the COVID-19 Local Fiscal Recovery Grant for the Borough.


