Minutes

January 18, 2022

The Borough of Ben Avon Council met in a regular voting session on Tuesday, January 18, 2022, virtually and at 7101 Church Avenue for the purpose of transacting General Business. President Richard Wagner presided and opened the meeting at 7:00 PM with the Pledge of Allegiance.

BOROUGH REPORTS

Mayor's Report – *there was no report*

Ohio Township Police Report – *See Attachment "A"*

Chief Hanny reported 63 calls in the past month as reflected in the service report with nothing out of the ordinary. Mr. Opiery expressed thanks to OTP on behalf of the Public Works Department for their continued assistance with enforcing the leaf and snow removal ordinances.

Emsworth Volunteer Fire Company Report – *See Attachment "B"*

Chief Kohl reported 5 calls for the month of December. He stated the transition to serve Ben Avon has gone smoothly thus far.

Solicitor's Report

Solicitor Pesillo reported ongoing negotiations with the Ben Avon Fire Company in vacating the building owned by the Borough. The balance of the Kilbuck contract money from 2021 was refunded, and a release sent to Kilbuck township officials for their signature. Mr. Pesillo also said he was forwarded the tax appeal for a resident and would be happy to represent the Borough if so desired.

Joint Planning Commission

Ms. Houska asked the Council to review the proposed ordinances sent out several months ago in addition to the county response and to reply with any feedback by February 1. Ms. Houska also requested a digital copy of the lot line revision up for review and the engineer's report be sent to the JPC prior to the upcoming monthly meeting.

FINANCIAL REPORTS

Revenue & Expense Report

Mr. Opipery stated that typically Council would be presented the prior month's financial statements, however, in January there are still pending invoices from the previous fiscal year. In the coming months, once all bills have cleared, the financial statements will be presented for approval. The Tax Rate Ordinance passed in December has set the formula for the tax rate to be set by resolution in February or March prior to the tax bills sent out later in the year.

Accounts Payable

Motion: Mr. Opipery; **Second:** Mr. Thornton; **Motion Carried** by unanimous voice vote to approve Accounts Payable in the amount of \$83,489.24.

COMMITTEE REPORTS

Administration Report

Ms. Bett reported that the Administration Committee will meet next week and lay out their agenda for the upcoming year. At this time, new Council members should have their new email addresses and access to Microsoft 360. She stressed the importance of all councilmembers using the Borough email addresses assigned to them for Borough business. Meetings will be moving over to the Teams platform, and meeting documents will be available on that system. When emailing Councilmembers, she asked that everyone limit the number of recipients to 2 or 3 to adhere to the Sunshine Laws.

Public Affairs & Communications

Ms. Bett stated updates have been made to the website and reminded new Council members to submit a picture and bio to be uploaded.

Mr. Wagner noted that there were two documents in the packet for the Council's review: the Northwest EMS quarterly report and the monthly report from Harshman. The Code Enforcement

Committee plans to meet monthly with Harshman, and once they are given access to the spreadsheet, will review the Google document for status updates.

Public Works

Mr. Wagner noted his thanks to the Public Works Department on behalf of the Council in their efforts of snow removal this season. Mr. Opiery stated the new hire, Shane Scigliano, has done a great job learning the system. He asked that residents be aware of snow removal efforts, and to refrain from blowing or shoveling snow onto the streets. He asked Chief Hanny to remind officers to aid in notifying residents when this happens.

Mr. Wagner reported that he and Ms. Washington met, and the regularly scheduled delegate meeting will be tomorrow evening. One of the topics for discussion is the recent Route 65 Corridor report, which will be presented on January 26 at the Sewickley Library.

Sustainability

Ms. Roggenkamp and Mr. Thornton will meet this coming Sunday. She had Climate Action Plan updates that the energy assessment required more information for review. She also remarked that the due date for applying for a summer intern is approaching mid-February. Mr. Wagner suggested that a possible project for the intern may be the Avon Park improvements. He also noted that the Building Project Committee meetings this year may focus on ADA compliance improvements at the Borough Building.

NEW BUSINESS

Avon Park Memorial

Mr. Thornton would like Council to consider some sort of memorial in Avon Park for a resident who was murdered in Pittsburgh. Ms. Bett plans to review the park lease, and there would need to be a discussion as to how best to proceed after getting more feedback.

Resolution 2022-01





Route 65 Study – Final Analysis & Recommendations – On 1-26-2022 members of the Remaking Cities Institute & Michael Baker International will be presenting the final report for the Route 65 Study. The presentation will include a comprehensive summary of the report as well as a list of recommendations moving forward. All are welcome to attend and participate in the event which will be held at the Sewickley Public Library (500 Thorn Street, Sewickley, PA 15143) beginning at 7:00 p.m. The meeting will be simulcast over Zoom for those unable to attend in-person. A condensed version of the presentation will be provided to the QVCOG Board of Directors at their January 19th Regular Meeting.

Recycling Performance Grant - The QVCOG recently submitted a joint application for an Act 101 Section 904 Recycling Performance Grant through the PA DEP for 14 of its member communities for the 2020 cycle. As noted in previous reports, the COG has used PRC for prior applications to aggregate its recycling data. By bringing this initiative in-house the COG will save \$5,000 in administrative fees. The reported data year over year (2019 vs. 2020) saw a slight increase for residential recyclable tonnage (+0.10%). In contrast, reported commercial tonnage increased by 68.3% for the 2020 application. The grant award is anticipated to be announced by the Spring of 2022. Participating members will receive their award based on their respective residential tonnage collected within 2020. The remainder of the grant (based on commercial tonnage) will be allocated towards the QVCOG’s shared recycling fund.

2022 Contact Info – Municipal Managers/Secretaries have been provided with a spreadsheet which will be used to update the COG’s elected officials contact information. Member communities are asked to relay the completed chart after their respective reorganization meetings. Member communities appointing a new QVCOG Delegate(s) are asked to contact Executive Director Conners as soon as possible.

Website Reboot – In effort to provide the most pertinent and useful information for interested parties the QVCOG has “rebooted” its webpage to establish a one-stop shop that highlights existing programming and educational opportunities available for member communities.

LGA Municipal Intern Program – Beginning January 10th applications will be accepted for the 2022 Local Government Academy Municipal Intern Program. Applications are due 2-15-2022. Interested parties may review past projects and program criteria by visiting localgovernmentacademy.org. Executive Director Conners has experience as both an intern and supervisor within this Program and would be happy to assist any member community with their project proposal. In effort to better connect with member communities and organizations within the region, the QVCOG is seeking selection as a host site during this cycle. The proposed Intern will engage with QVCOG member communities, nearby COGs, and other local institutions to benchmark existing organizational structures and programming to generate a strategic plan to best serve its 15 member communities.

Glass Recycling – The QVCOG is seeking a volunteer municipality to serve as its first host site for a shared 20-yard glass recycling receptacle. The prospective host community can offer its residents convenient access to recycle their glass and will serve as a flag bearer leading our region towards the ever-growing goal of sustainability. The host community will be asked to periodically monitor the dumpster to ensure that the stated rules are being followed and must notify the QVCOG when the vessel needs serviced. Communities interested in hosting this resource are asked to highlight a viable location (central access, lighting, and periodic supervision required) within a letter of interest to the QVCOG no later than February 1, 2022.
